### 4<sup>TH</sup> LVFO-ECOFISH PROJECT STEERING COMMITTEE (PSC) MEETING

## 29<sup>TH</sup> – 30<sup>TH</sup> MARCH 2023; KISUMU - KENYA

### 1.0 Background

Lake Victoria Fisheries Organization (LVFO) is implementing a programme called "Contribution of Sustainable Fisheries to the Blue Economy of the Eastern Africa, Southern Africa and the Indian Ocean Region –  $E \notin OFISH$  programme". The funding is Euro 2 million to LVFO for activities implemented in the Republics of Kenya, Uganda and the United Republic of Tanzania.

The overall objective is to enhance equitable economic growth by promoting sustainable fisheries in the EA-SA-IO region. The specific objective is to support sustainable management and development of fisheries, while addressing climate change resilience and enhancing marine biodiversity. On Lake Victoria, the purpose of the Programme is to support sustainable management and development of fisheries resources.

The ECOFISH programme came into force in September 2018 when the Agreement was signed between the European Union and the Indian Ocean Commission (*IOC*). LVFO initially signed a Start Up Programme Estimate with IOC and EU Mauritius to be implemented for a period of four months, from 25<sup>th</sup> October 2019 to 24<sup>th</sup> February 2020.

During the implementation phase of Program Estimate (*PE*) 1 and 2 a number of achievements have been made in Results Areas 1 and 2 (*Annex 1*) necessitating review and consideration by the next PSC.

#### 2.0 **Programme Steering Committee (***PSC***)**

Under the project implementation arrangements, it was envisaged that the project requires high level policy guidance for efficient implementation. LVFO instituted a Policy Steering Committee (*PSC*) composed of 13 members as follows: The 3 Directors of Fisheries Management from Partner States (*Kenya, Tanzania and Uganda*), EU Delegation in Uganda (1); EU Delegation in Mauritius (*Technical Coordinator & TL/ECOFISH*); Fisheries MCS Expert- ECOFISH Project (*IOC*) Office; Operations Advisor- European Union Delegation to Uganda and Project Manager - EU Delegation Mauritius (4), Representative of Industry (1), Representative of Beach Management Unit networks (*BMU regional network - 1*), LVFO Executives (2) LVFO Director Fisheries Monitoring and Research and Director Fisheries Management and Development/Project Coordinator (1). This is detailed in section 3. The meeting is held once a year to provide policy guidance to the implementation.

The first meeting was held on 24<sup>th</sup> January 2020 at Imperial Express Hotel, Kisumu, Kenya; the 2<sup>nd</sup> in Dar es-Salaam, Tanzania from 29<sup>th</sup> to 30<sup>th</sup> June 2021 and the 3<sup>rd</sup> meeting on 2<sup>nd</sup> to 3<sup>rd</sup> June 2022 at Kabira Country Club, Kampala, Uganda.

This 4<sup>th</sup> PSC is scheduled to take place from 29<sup>th</sup> to 30<sup>th</sup> March, 2023 in Kisumu, Kenya and the meeting will consider the progress of implementation of project activities and provide policy guidance. The meeting will be co-chaired by the current Chairperson of the Senior Official and the LVFO Executive Secretary. The 1<sup>st</sup> day of the meeting will consider technical aspects of the project and the 2<sup>nd</sup> day policy matters - *It is also planned that a regional consultative multi-stakeholder meeting to harmonize MCS operation on Lake Victoria be held back-to-back with this LVFO Project Steering Committee meeting to extend guidance.* 

The Concept Note for the regional consultative multi-stakeholders meeting (*31<sup>st</sup> March 2023*) is attached separately.

- f) Backstopping and capacity building of LVFO project staff by IOC project officials
